**COMPULSORY PURCHASE OF LAND IN THE  
COMMUNITY OF MAGOR AND UNDY, IN  
THE COUNTY OF MONMOUTHSHIRE**

The Welsh Ministers have prepared in draft The Welsh Ministers (The M4 Motorway (Junction 23 (East of Magor) to West of Junction 29 (Castleton) and Connecting Roads) and the M48 Motorway (Junction 23 (East of Magor) Connecting Road) and The London to Fishguard Trunk Road (East of Magor to Castleton)) Supplementary (No. 2) Compulsory Purchase Order 201-, under sections 239, 240 and 260 of the Highways Act 1980 and under section 2 of, and paragraph 1(1)(b), (3) and (4) of Part 1 of Schedule 2 to, the Acquisition of Land Act 1981. The Welsh Ministers are about to make this Supplementary (No. 2) Order and if made the Supplementary (No. 2) Order will authorise the Welsh Ministers to purchase compulsorily the land described below for the purpose of:-

- (a) the construction and improvement of highways, including a special road, and the provision of new means of access to premises and the carrying out of other works, in the Community of Magor and Undy in the County of Monmouthshire, in pursuance of The M4 Motorway (Junction 23 (East of Magor) to West of Junction 29 (Castleton) and Connecting Roads) and the M48 Motorway (Junction 23 (East of Magor) Connecting Road) and the London to Fishguard Trunk Road (East of Magor to Castleton) (Side Roads) Order 201-;
- (b) use by the Welsh Ministers in connection with such construction and improvement of highways and the execution of the works mentioned above.
