

## Non-Technical Summary

---

1. Draft Orders for the proposed M4 Corridor around Newport (M4CaN) were published by Welsh Government in March 2016, together with an Environmental Statement (ES) and associated reports.
2. M4CaN (referred to in this document as 'the Scheme') includes a proposed new section of three lane motorway between Castleton (Junction 29 of the existing M4) and Magor (Junction 23 of the existing M4) to the south of Newport in South Wales, together with a number of Complementary Measures on the existing M4 between the same junctions.
3. In September 2016 an Environmental Statement Supplement (ESS) was published (the September 2016 ESS) which provided errata; clarified some aspects of the cultural heritage assessment, and impacts during construction; provided the results of some of the 2016 ecological surveys; and provided updated or additional information to a number of appendices, including the Register of Environmental Commitments.
4. The final part of the September 2016 ESS described and assessed a number of modifications to the Scheme design since the publication of the draft Orders and consequential modifications to the Environmental Management Plans. The more significant design modifications were at the Magor Interchange where Bencroft Lane was realigned and at Docks Way junction.
5. A second supplement to the ES was published in December 2016 which provided errata, supplementary information which became available since the publication of the September 2016 ESS and an assessment of the modifications of the Scheme design. The Scheme design changes assessed within the December 2016 ESS included; changes to future year road traffic forecasts, vertical height adjustments of the Usk Crossing, changes to the retaining structures of the Docks Way Link Road, and an additional borrow pit at Magor.
6. In March 2017 a further modification to the design was made in the form of an additional eastbound off-slip at Magor. The design change required a modification to the published draft Statutory Orders. This was reported and the environmental implications assessed in a third Environmental Statement Supplement (the March 2017 ESS).
7. The design modification that is the subject of this fourth supplement (the April 2017 ES Supplement) is in respect of bridge protection measures to the south and to the north of the Junction Cut within Newport Docks.
8. This supplement and the previous Environmental Statement Supplements should be read together and alongside the published March 2016 ES. None of the additional data provided in the April 2017 ESS materially alters the assessment and conclusions of the March 2016 ES.

# Crynodeb Annhechnegol

1. Cyhoeddwyd Gorchmynion drafft ar gyfer cynllun arfaethedig Coridor yr M4 o amgylch Casnewydd gan Lywodraeth Cymru ym mis Mawrth 2016, ynghyd â Datganiad Amgylcheddol a'r adroddiadau cysylltiedig.
2. Mae cynllun Coridor yr M4 o amgylch Casnewydd (y cyfeirir ato yn y ddogfen hon fel 'y Cynllun' yn cynnwys rhan newydd arfaethedig o draffordd tair lôn rhwng Cas-bach (Cyffordd 29 llwybr presennol yr M4) a Magwyr (Cyffordd 23 llwybr presennol yr M4) i'r de o Gasnewydd yn Ne Cymru, ynghyd â nifer o Fesurau Ategol ar lwybr presennol yr M4 rhwng y cyffyrdd hynny.
3. Ym mis Medi 2016, cyhoeddwyd Datganiad Amgylcheddol Atodol (Datganiad Amgylcheddol Atodol mis Medi 2016) a oedd yn darparu rhestr gwallau; yn egluro rhai agweddau ar yr asesiad treftadaeth ddiwylliannol, ac effeithiau yn ystod y gwaith adeiladu; yn rhoi canlyniadau rhai arolygon ecolegol a gynhaliwyd yn ystod 2016; ac yn rhoi gwybodaeth ychwanegol neu wybodaeth wedi'i diweddarau ynglŷn â nifer o atodiadau, gan gynnwys y Gofrestr Ymrwymadau Amgylcheddol.
4. Roedd rhan olaf Datganiad Amgylcheddol Atodol mis Medi 2016 yn disgrifio ac asesu nifer o addasiadau i ddyluniad y Cynllun ers cyhoeddi'r Gorchmynion drafft ac addasiadau canlyniadol i'r Cynlluniau Rheoli Amgylcheddol. Roedd yr addasiadau dylunio mwy arwyddocaol wrth Gyfnewidfa Magwyr, lle yr ailaliniwyd Lôn Bencroft, ac wrth gyffordd Ffordd y Dociau.
5. Cyhoeddwyd atodiad i'r Datganiad Amgylcheddol ym mis Rhagfyr 2016 a roddodd restr gwallau, gwybodaeth ychwanegol a oedd wedi dod i'r amlwg ers cyhoeddi Datganiad Amgylcheddol Atodol mis Medi 2016 ac asesiad o'r addasiadau i ddyluniad y Cynllun. Roedd y newidiadau i ddyluniad y Cynllun a aseswyd yn Natganiad Amgylcheddol Atodol mis Rhagfyr 2016 yn cynnwys; newidiadau i ragolygon traffig ffordd yn y dyfodol, addasu uchder fertigol Croesfan Afon Wysg, newidiadau i adeileddau cynhaliol Ffordd Gyswllt Ffordd y Dociau, a phwll benthyg ychwanegol ym Magwyr.
6. Gwnaed addasiad arall i'r dyluniad ym mis Mawrth 2017 yn ymwmneud a ffordd ymadael ychwanegol tua'r dwyrain ym Magwyr. Mi oedd angen addasiad i'r Gorchmynion Statudol o achos yr addasiad yma i'r cynllun. Cafodd effeithiau amgylcheddol y newid yma ei asesu a'l reportio mewn trydydd Datganiad Amgylcheddol Atodol (Datganiad Amgylcheddol Atodol Mis Mawrth 2017)
7. Mae'r addasiad i'r cynllun caiff ei asesu yn y bedwerydd atodiad yma (Datganiad Amgylcheddol Atodol Mis Ebrill 2017) yn ymwmneud a gweithfeydd amddiffyn pont i'r gogledd ac i'r de o'r Gyffordd Torri o fewn Dociau Casnewydd.
8. Dylid darllen y Datganiad Amgylcheddol Atodol yma, a'r Datganiadau Amgylcheddol Atodol eraill ochr yn ochr â Datganiadau Amgylcheddol Atodol a gyhoeddwyd ym mis Mawrth 2016.
