Mae'r prosiect hwn yn ddarostyngedig i Asesiad o'r Effaith Amgylcheddol yn unol â Rhan VA o Ddeddf Priffyrdd 1980 (fel y'i diwygiwyd) a Chyfarwyddeb 2011/92/EU y GE. Gan hynny, cyhoeddodd Gweinidogion Cymru Ddatganiad Amgylcheddol (DA) ar 10 Mawrth 2016.

Mae'r prosiect hefyd yn ddarostyngedig i Asesiad o'r Goblygiadau ar gyfer Safleoedd Ewropeaidd (AGSE) yn unol â Rheoliadau Gwarchod Cynefinoedd a Rhywogaethau 2010 ac Erthygl 6(3) o Gyfarwyddeb Cynefinoedd 92/43/EC. Gan hynny, mae Gweinidogion Cymru wedi cyhoeddi Datganiad i Hysbysu Asesiad Priodol (DHAP) ar 10 Mawrth 2016.

The Welsh Ministers are considering implementing a project for the construction of a new section of M4 motorway to the south of Newport to include online and off line works and side road improvements. This project is subject to an Environmental Impact Assessment in accordance with Part VA of the Highways Act 1980 (as amended) and EC Directive 2011/92/EU. Therefore the Welsh Ministers published an Environmental Statement (ES) on 10 March 2016.

The project is also subject to an Assessment of Implications on European Sites (AIES) in accordance with the Conservation of Habitats and Species Regulations 2010 and Article 6(3) of the Habitats Directive 92/43/EC. Therefore the Welsh Ministers published a Statement to Inform an Appropriate Assessment (SIAA) on 10 March 2016.

Following publication of the ES, four Environmental Statement Supplements (ESS) were published on 5 September 2016, 13<sup>th</sup> December 2016, 21 March 2017 and 20 April 2017. These provide errata, additional data and clarifications, and an environmental assessment of scheme design changes between March 2016 and May 2017. All supplements and the ES should be read together.

Following discussions with the owners and operators of Newport Docks, certain assets and commercial tenants affected by the proposed scheme are to be relocated within the Docks. The further Environmental Statement Supplement (ESS5) and an Addendum Statement to Inform an Appropriate Assessment (ASIAA) have been prepared to assess the environmental effects of those relocations and to update the bridge protection measures set out in ESS4.

This ESS5 and ASIAA were published on 15 August 2017 and should be read in conjunction with the published ES and Non-Technical Summary, ESS, ESS2, ESS3, ESS4 and SIAA, which remain valid.
